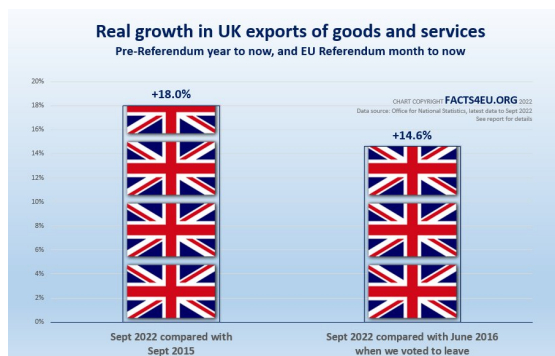

1. Using 'Chained Volume Measures' (to take out the effect of price inflation)

Comparing Sept 2015 (before the Referendum) to the same month (Sept) in 2022

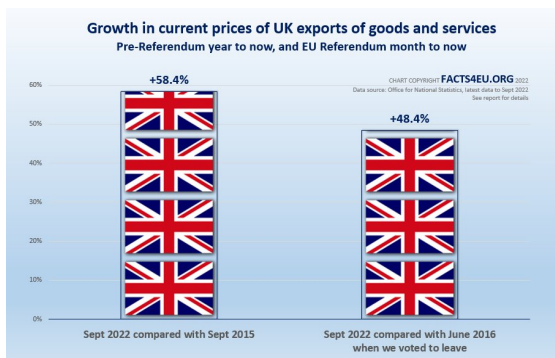


- **UP 18.0%** – Sept 2022 compared with Sept 2015
- **UP 14.6%** – Sept 2022 compared with June 2016 when we voted to leave

2. Using 'Current Prices' – actual value of exports in each time period



- **UP 58.4%** – Sept 2022 compared with Sept 2015
- **UP 48.4%** – Sept 2022 compared with June 2016 when we voted to leave
